GOLF CAR SEASONAL RENTAL AGREEMENT 2010

THE FOLLOWING CONDITIONS APPLY TO THE SEASONAL RENTAL OF A GOLF CAR. THESE CONDITIONS SHALL BE ENACTED AND ENFORCED BY THE CLUB PROFESSIONAL OR HIS DESIGNATE.

1. THE RENTER SHALL GIVE THE PROSHOP **12 HOURS ADVANCE NOTICE** OF THE DESIRE TO UTILIZE A GOLF CAR. SHOULD LESS NOTICE BE GIVEN, AVAILABILITY CANNOT BE GUARANTEED.
2. THE GOLF CAR RENTED SHALL NOT BE A SPECIFIC CAR, BUT ONE IN GOOD WORKING ORDER ASSIGNED BY THE PROFESSIONAL OR DESIGNATE
3. GOLF CARS SHALL NOT BE USED AT SUCH TIMES THAT THE COURSE SUPERINTENDENT DEEMS THAT DUE TO COURSE CONDITIONS, THE USE OF GOLF CARS WILL BE DETRIMENTAL TO THE COURSE.
4. A GOLF CAR MAY NOT BE USED FOR MORE THAN 36 HOLES IN ANY 24 HOUR PERIOD.
5. THE GOLF CAR WILL BE RETURNED IMMEDIATELY UPON COMPLETION OF 18 HOLES OF PLAY, IN THE SAME CONDITION AS IT WAS RECEIVED, ALLOWANCES MADE FOR DETERIORATION FROM ORDINARY USE. THE CONTRACT HOLDER WILL BE CHARGED FOR ANY DAMAGES SUSTAINED TO THE GOLF CAR WHILE UNDER HIS/HER CONTROL
ALL CARTS MUST BE RETURNED TO PRO SHOP NO LATER THAN ½ HOUR AFTER THE OFFICIAL PRO SHOP POSTED SUNSET.
6. **SINGLE:** HOLDER OF A SINGLE CONTRACT MAY BOOK AND USE A GOLF CAR , THE OTHER SEAT TO BE RENTED OUT BY THE GOLF CLUB WHENEVER POSSIBLE. WHEN PRACTICABLE, TWO CONTRACT HOLDERS WILL BE ASSIGNED TO **ONE CAR**.
7. **COUPLE:** EITHER SPOUSE MAY BOOK AND USE A GOLF CAR, ANYTIME THE SECOND SEAT IS NOT BEING USED BY A SPOUSE, THAT SEATMAY BE ASSIGNED TO ANOTHER CONTRACT HOLDER OR RENTED AT THE APPROPRIATE RATE.
8. **THE CONTRACT HOLDER ONLY IS ALLOWED TO USE THE GOLF CAR AND MAY NOT, UNDER ANY CIRCUMSTANCES TRANSFER THE PRIVILEGE TO ANOTHER PERSON.**
